## WHO WE HELP | PRO BONO CENTER

Volunteers are at the heart of the Pro Bono Center's work, allowing us to reach many more people than our small staff could do on its own. A new legal clinic in Carnegie Borough takes attorneys to where the clients are, eliminating the need for community members to spend time and money making a trip to Downtown Pittsburgh. The generous and experienced volunteers give advice on issues from family law to estate planning to public benefits.



#### LIFE CHANGING SERVICES



The Pro Bono Center is sometimes the first stop – and the last resort – for people seeking help that is not available anywhere else.

"Joe" was homeless and had been denied Social Security benefits because the name he had used his entire life – and which was on his Social Security card – did not match the name on his official birth certificate. He needed a court-ordered name change, and he had absolutely no ability to pay for an attorney. His issue did not fall within the scope of any other legal aid

organization or pro bono program, so he turned to the Pro Bono Center as his last hope.

We took the case, obtained a fee waiver for court costs, and secured a final name change order. After presenting the order to the Social Security Administration, Joe was awarded ongoing benefits plus a retroactive lump sum. He used the money to pay the deposit and first month's rent on an apartment, and his new monthly benefits will allow him to remain housed. This was a simple case for the Pro Bono Center, but life changing for our client, who could not have done it on his own.



#### PARDONS PROJECT SEEING SUCCESSES

The Pardons Project launched in 2020 in response to the need of individuals with old criminal records re-entering the job force as COVID shutdowns began to ebb. The process for pardoning criminal offenses in Pennsylvania is long – sometimes taking 3 to 4 years from application to decision. So cases that were filed in 2020 have only just begun showing results – including clearing the record of a client whose possession of marijuana conviction from over 30 years ago was still holding her back from better job opportunities.












## WHO WE HELP | JUVENILE COURT PROJECT



#### HELPING CLIENTS IN NEED

In Fiscal Year 2023-24 the Juvenile Court Project (JCP) represented nearly 1,000 clients and participated in nearly 6,700 hearings concerning our clients' 2,300 court active children. Additionally, the JCP support staff received over 2,000 referrals and assisted clients with finding housing, finding community resources, developing family finding ecomaps, attending court hearings, and retrieving records (medical, treatment, education, visitation, etc.). The JCP support staff attended over 700 Family Conferencing and Teaming meetings, as well as other case planning and child educational meetings. The support staff conducted over 2,000 check-in calls with clients. The JCP paralegal team contributed support by drafting motions, acquiring transcripts, issuing subpoenas, drafting appellate pleadings, conducting intake, and legal research.

The JCP finished work with a software consulting firm to create a Client Database report writing tool and worked with a website developer to redesign the JCP website. The JCP continues to zealously pursue appellate advocacy for our clients and works collaboratively with other child welfare attorneys in appellate practice by seeking out amicus supports and opportunities.

#### WHO WE SERVE | ATTORNEYS AGAINST HUNGER



Through the Attorneys Against Hunger (AAH) campaign, the Allegheny County Bar Foundation is helping address the complex challenges faced by our neighbors in need of assistance. Some individuals, including those who've fled domestic abuse or lost their homes, are now living in their cars and seeking food that doesn't require a kitchen. With the support of Attorneys Against Hunger, Jewish Family and Community Services has been able to offer specialized food bags containing shelf-stable and ready-to-eat items like peanut butter, canned tuna, and fresh fruit – items that are not typically available.

This targeted approach, made possible by Attorneys Against Hunger funds, ensures that even people without access to a kitchen receive nutritious, ready-to-eat meals. By tailoring food distribution to meet the unique needs of those living without stable housing, the program is empowered to fill a gap that many pantries often struggle to address.

#### STRIKE OUT HUNGER

The ACBA's Young Lawyers Division (YLD) sponsored Strike Out Hunger, a fundraiser supporting Attorneys Against Hunger. The event was held at Shorty's Pins x Pints on the North Shore on April 30, 2024 where participants enjoyed duck pin bowling, arcade games, and a shuffleboard tournament. The event raised nearly \$7,000 of crucial support to the AAH campaign. Thank you to all the YLD members and attendees who helped to make the event so successful!

#### HELPING THOSE IN NEED

The "new home essentials kits" were a highly needed tangible that Allies for Health + Wellbeing was able to provide thanks to the ACBF Grant, and they benefited people who would otherwise have no options to cook or eat. It has provided nutrition and sustenance to people and allowed those who needed food to take their medications to be able to continue taking them. Many people have expressed being deeply grateful.

## WHAT WE DO | FELLOWS GIVE



In 2022, we launched the new, improved, and revamped Fellows GIVE which directly connects you to the programs that make a difference. Our distinguished Fellows GIVE attorneys are dedicated to improving the community and profession. Active Fellows GIVE members vote on programs and empower the organizations to do more by providing grants.

On October 25, 2023, active Fellows GIVE members came together to hear pitches from ten eligible legal aid organizations. Attending Fellows members then voted on which ones they would like to receive one of six \$10,000 grants.

Through the Fellows GIVE Program, the ACBF supports organizations in Allegheny County that are working to close the justice gap through innovative programs and projects.

In FY 2023-24, \$60,000 in grants were awarded to the following six legal aid programs of varying focus, including immigration services, support for survivors of intimate partner violence, access to education, tenants' rights, and more that are meeting the crucial and urgent needs in our community.

## FELLOWS GIVE GRANTS

#### SUCCESS STORIES

"Nonnie" is a Section 8 voucher renter. A little over two years ago, her rent portion was adjusted without notice from the Housing Authority from \$126 to \$355. Nonnie continued to pay \$126 for over two years with no objection from the landlord. The landlord finally internally audited their properties, noticed that they had been missing \$229 every month for over two years, and filed an eviction action against Nonnie which included a \$6,481 claim for the accumulated balance. At trial, both parties testified that they never received a notice from Section 8. Neighborhood Legal Services (NLS) attorneys successfully argued that the onus to catch Section 8's mistake was on the landlord, and that they should not be able to spring such a cumbersome debt on a fault-free client after two years of sitting on their hands.

### HOW WE EDUCATE | LAW STUDENT SUPPORT



The ACBF offers funded fellowships every summer made possible by members of the legal community. We aim to promote the path of public interest as a viable career opportunity and level the playing field by offering resources and professional development to students.

#### SUMMER FELLOWSHIP SPOTLIGHTS



"This summer, I interned at Neighborhood Legal Services (NLS) in the Housing division. As a certified intern, I was assigned my own clients in landlord-tenant matters, and I was able to get the full experience of client representation. I conducted the initial client intakes, researched the issue in question, and consulted one of my supervising attorneys to determine the best action plan for the client. For some of my clients, I was able to represent them in Magistrate Court hearings and Common Pleas Court arbitrations.

I cannot overstate how much I enjoyed working at NLS this summer.

Not only did I learn the substantive law very well, but the practical

experience of working with clients and litigating inside of a courtroom was incredible. Also, the mentorship that you receive at NLS is truly unique and exceptional. My main supervising attorney, Danielle Harrington, was always available to answer questions and guide me when needed. In addition to this, I had six other Housing attorneys available to me who I would go to regularly for advice and guidance and who always made themselves available to me. I highly recommend this internship for any student who is craving that practical lawyering experience that we often feel like we're missing out on when sitting in a classroom.

Lastly, and most importantly, this experience was only possible because of the Gismondi Fellowship. I am financially supporting myself through law school with loans and waitressing, so this fellowship was the only way I was able to have this incredible experience. I am extremely grateful to have been chosen, and it's fellowships like this one that enables the proliferation of public interest law and public service in Pittsburgh. I look forward to passing on all the skills and knowledge that I acquired this summer to future law students when I become a mentor myself."






Total Revenue \$460,401
